WE ARE CONSTANTLY ADJUSTING OUR BEHAVIOR, LANGUAGE, AND EVEN APPEARANCE BASED ON THE CONTEXT AND THE AUDIENCE.

PERFORMANCE: THIS ENCOMPASSES ALL THE ACTIONS, WORDS, AND BEHAVIORS AN INDIVIDUAL USES TO CREATE A SPECIFIC IMPRESSION. IT INCLUDES BOTH VERBAL AND NONVERBAL CUES.

ROLE AND ROLE PERFORMANCE: A ROLE IS A SOCIALLY DEFINED EXPECTATION OF BEHAVIOR. ROLE PERFORMANCE IS HOW AN INDIVIDUAL FULFILLS THAT ROLE. THE SAME INDIVIDUAL MIGHT PERFORM THE ROLE OF "STUDENT" DIFFERENTLY DEPENDING ON THE CONTEXT (A LECTURE VERSUS A STUDY GROUP).

TEAMWORK: SUCCESSFUL PERFORMANCES OFTEN INVOLVE COLLABORATION. INDIVIDUALS MAY WORK TOGETHER TO CREATE A UNIFIED AND CONVINCING IMPRESSION, COORDINATING THEIR ACTIONS AND BEHAVIOR.

IDEALIZATION: PERFORMANCES OFTEN AIM TO PRESENT AN IDEALIZED VERSION OF THE SELF, SHOWCASING DESIRABLE TRAITS AND CONCEALING FLAWS. THIS ISN'T NECESSARILY DISHONESTY; IT'S A STRATEGIC PRESENTATION OF SELF.
