POORLY DEFINED RESEARCH QUESTIONS OFTEN LEAD TO INCONCLUSIVE RESULTS.

LITERATURE REVIEW PROFICIENCY: CONDUCTING A THOROUGH LITERATURE REVIEW IS ESSENTIAL TO ESTABLISH THE CONTEXT OF YOUR RESEARCH, IDENTIFY GAPS IN EXISTING KNOWLEDGE, AND INFORM YOUR METHODOLOGY. THIS REQUIRES MASTERING VARIOUS COMMUNICATION METHODS, INCLUDING WRITING RESEARCH REPORTS, PRESENTING AT CONFERENCES, AND PREPARING POLICY BRIEFS. POOR COMMUNICATION CAN RENDER EVEN EXCELLENT RESEARCH INEFFECTIVE.
