However, many critics argue that Marlowe's Dr. Faustus owes a lot to the medieval dramatic tradition, to be precise, to the morality play tradition. Describing different types of the medieval plays, Philip Tilling claims that "the morality play as a kind of medieval religious play arose alongside the mystery play and was to continue, in modified form, throughout the Elizabethan period, culminating in Marlowe's Faustus." So, Tilling considers Dr. Faustus to be "a morality play in a modified form".
