ANSWER: TERM LIFE INSURANCE PROVIDES COVERAGE FOR A SPECIFIED PERIOD (THE TERM), AFTER WHICH THE COVERAGE EXPIRES. WHOLE LIFE INSURANCE PROVIDES LIFELONG COVERAGE, BUILDING CASH VALUE THAT GROWS TAX-DEFERRED.

QUESTION 4: WHAT IS THE PURPOSE OF A BENEFICIARY DESIGNATION ON A LIFE INSURANCE POLICY?

ANSWER: A BENEFICIARY DESIGNATION SPECIFIES WHO WILL RECEIVE THE DEATH BENEFIT UPON THE INSURED'S DEATH. WITHOUT A BENEFICIARY DESIGNATION, THE DEATH BENEFIT MAY GO THROUGH PROBATE, DELAYING DISBURSEMENT TO THE INTENDED RECIPIENTS.

QUESTION 5: WHAT ARE SOME COMMON EXCLUSIONS FOUND IN LIFE INSURANCE POLICIES?

ANSWER: COMMON EXCLUSIONS CAN INCLUDE DEATH RESULTING FROM SUICIDE (OFTEN WITHIN A SPECIFIC TIMEFRAME), DEATH RESULTING FROM PARTICIPATION IN ILLEGAL ACTIVITIES, OR DEATH RESULTING FROM PRE-EXISTING CONDITIONS (DEPENDING ON POLICY SPECIFICS AND DISCLOSURE DURING THE APPLICATION PROCESS).
