Wellness travelers may seek procedures or treatments using conventional, alternative, complementary, herbal, or homeopathic medicine. This type of consumer seeks to look and feel better, to lose weight, to slow

the effects of aging, to relieve pain or discomfort, to manage stress, or to partake in the use of natural supplements like vitamins and minerals to improve their health. Resorts and hotels are joining the health spa development craze, although only some resorts are moving into the scope of services currently offered by destination spas. Likewise, a growing number of day spas are adding health and wellness programming options. Health tourism refers to those clients with medical conditions who would travel to experience healing therapies. A person who seeks a wellness travel experience, is generally healthy to start with, and seeks therapies to maintain his or her well-being. The spa industry segment is regarded as the leading player in health and wellness tourism.
