EQUIFAX: SIMILAR TO EXPERIAN, EQUIFAX PROVIDES A DEDICATED ONLINE PORTAL FOR BUSINESS CREDIT DISPUTES. MAKE SURE TO UPLOAD CLEAR, LEGIBLE COPIES OF YOUR SUPPORTING DOCUMENTS.

DUN & BRADSTREET: DUN & BRADSTREET'S PROCESS MIGHT INVOLVE CONTACTING THEIR CUSTOMER SERVICE DIRECTLY OR USING AN ONLINE FORM. THEIR WEBSITE WILL OUTLINE THE SPECIFIC STEPS REQUIRED FOR ADDRESS CORRECTION.

THOROUGHLY COMPLETE EACH CREDIT BUREAU'S DISPUTE FORM, PROVIDING ACCURATE DETAILS.

INCLUDE YOUR BUSINESS NAME, TAX ID NUMBER, THE INCORRECT ADDRESS, AND THE CORRECT ADDRESS. ATTACH COPIES OF YOUR SUPPORTING DOCUMENTATION. REMEMBER TO KEEP COPIES OF ALL SUBMITTED DOCUMENTATION FOR YOUR RECORDS.

THIS PROVIDES VERIFIABLE PROOF THAT YOUR DISPUTE WAS RECEIVED BY THE CREDIT BUREAU. WHILE ONLINE METHODS ARE OFTEN QUICKER, CERTIFIED MAIL OFFERS ADDED SECURITY AND A DOCUMENTED TRAIL OF CORRESPONDENCE.

REGULARLY REVIEW AND UPDATE YOUR BUSINESS INFORMATION WITH ALL RELEVANT ENTITIES.

MAKE REVIEWING AND UPDATING YOUR BUSINESS ADDRESS A REGULAR PART OF YOUR ADMINISTRATIVE TASKS. THIS PROACTIVE APPROACH HELPS PREVENT INACCURACIES FROM ACCUMULATING.
