A3: A SOLID WHITE LINE SEPARATES LANES OF TRAFFIC MOVING IN THE SAME DIRECTION. GENERALLY, CROSSING A SOLID WHITE LINE IS DISCOURAGED UNLESS ABSOLUTELY NECESSARY, SUCH AS FOR AN EMERGENCY OR TO MAKE A TURN.

Q4: WHAT DOES A DIAMOND-SHAPED SIGN INDICATE?

A4: A DIAMOND-SHAPED SIGN TYPICALLY INDICATES A WARNING, ALERTING YOU TO POTENTIAL HAZARDS AHEAD, SUCH AS CURVES, HILLS, OR CONSTRUCTION ZONES.

Q4: WHAT IS THE LEGAL BLOOD ALCOHOL CONTENT (BAC) LIMIT FOR DRIVING IN NEW JERSEY?

A4: THE LEGAL BAC LIMIT IN NEW JERSEY IS 0.08%. DRIVING UNDER THE INFLUENCE OF ALCOHOL OR DRUGS IS ILLEGAL AND DANGEROUS.
