Much here will be new to historians, including the first complete account of the British Free Corps - the Waffen-SS unit composed entirely of British subjects - and the identity of all its members, some of whom have been interviewed for this book. Also revealed is the extraordinary career of the conman who joined the Special Air Service and who, after capture by the Germans, informed on his POW camp comrades before volunteering to fight with the Waffen-SS on the Russian front; and in France, the story of the middle-aged British spinster who joined the Gestapo. Though regarded as highly dangerous at the time, German efforts to cultivate traitors in British ranks were for the most part stunningly unsuccessful - not least, as this book reveals, because much of that effort was entrusted to a British Fascist turned double agent at work in the heart of the Third Reich.
