MINISTRY OF THE ALTAR: ASSISTING THE PRIEST OR PASTOR DURING LITURGICAL SERVICES, PREPARING THE ELEMENTS FOR COMMUNION, AND ASSISTING WITH OTHER CEREMONIAL ASPECTS OF WORSHIP.

MINISTRY OF CHARITY: SERVING THE NEEDS OF THE COMMUNITY, PARTICULARLY THE POOR, VULNERABLE, AND MARGINALIZED. THIS CAN INVOLVE ACTS OF SERVICE, ADVOCACY, AND PROVIDING PRACTICAL SUPPORT.

PASTORAL CARE: OFFERING SPIRITUAL GUIDANCE, COMFORT, AND SUPPORT TO INDIVIDUALS AND FAMILIES WITHIN THE CONGREGATION. THIS REQUIRES COMPASSION, EMPATHY, AND ACTIVE LISTENING SKILLS.

INTERVIEWS AND ASSESSMENTS: THE CANDIDATE UNDERGOES A SERIES OF INTERVIEWS WITH CHURCH LEADERS, ASSESSING THEOLOGICAL UNDERSTANDING, SPIRITUAL MATURITY, AND COMMITMENT TO SERVICE. THIS MAY INVOLVE WRITTEN EXAMINATIONS OR PRESENTATIONS.

THEOLOGICAL EDUCATION: MANY DENOMINATIONS REQUIRE COMPLETION OF SPECIFIC THEOLOGICAL COURSES OR PROGRAMS, PROVIDING FOUNDATIONAL KNOWLEDGE IN BIBLICAL STUDIES, THEOLOGY, AND CHURCH HISTORY. THE EXTENT OF EDUCATION REQUIREMENTS VARIES.

ORDINATION SERVICE: THE CULMINATION OF THE PROCESS IS THE ORDINATION SERVICE, A FORMAL CEREMONY WHERE THE CANDIDATE RECEIVES THE LAYING ON OF HANDS AND OFFICIAL RECOGNITION AS A DEACON.
