PLACE TOOTHBRUSH IN HOLDER.

1. BODY FUNCTIONS AND STRUCTURES ANALYSIS:

FINE MOTOR SKILLS: DEXTERITY IN UNSCREWING AND SCREWING CAPS, PRECISE HAND MOVEMENTS FOR APPLYING TOOTHPASTE AND BRUSHING.

MUSCLE STRENGTH: STRENGTH IN HANDS AND WRISTS TO MANIPULATE TOOTHBRUSH AND APPLY SUFFICIENT PRESSURE.

RANGE OF MOTION: SUFFICIENT RANGE OF MOTION IN WRISTS, ELBOWS, AND SHOULDERS TO REACH ALL AREAS OF THE MOUTH.

COGNITIVE FUNCTION: REMEMBERING THE STEPS INVOLVED AND MAINTAINING ATTENTION DURING THE TASK.

1. PERFORMANCE SKILLS ANALYSIS:

MOTOR SKILLS: DEXTERITY, STRENGTH, AND COORDINATION ARE NEEDED FOR MANIPULATING THE TOOTHBRUSH AND TOOTHPASTE.

PROCESS SKILLS: SEQUENCING STEPS, PROBLEM-SOLVING IF DIFFICULTY ARISES (E.G., TOOTHPASTE TUBE IS DIFFICULT TO SQUEEZE).

1. MODIFICATIONS AND ADAPTATIONS:

BASED ON THE ANALYSIS, MODIFICATIONS MIGHT INCLUDE:

USING A LARGER, EASIER-TO-GRIP TOOTHBRUSH HANDLE.

USING A TOOTHPASTE PUMP DISPENSER INSTEAD OF A TUBE.

USING ADAPTIVE EQUIPMENT SUCH AS A LONG-HANDLED TOOTHBRUSH.

ADJUSTING SINK HEIGHT.

BREAKING DOWN THE TASK INTO SMALLER, MORE MANAGEABLE STEPS.

PROVIDING VERBAL OR VISUAL CUES.
