THIS INCLUDES INFORMATION ON CORPORATIONS, LIMITED LIABILITY COMPANIES (LLCS), PARTNERSHIPS, AND OTHER BUSINESS ENTITIES. THEIR ROLE IS ESSENTIAL FOR MAINTAINING THE INTEGRITY OF BUSINESS RECORDS AND PROVIDING PUBLIC ACCESS TO THIS CRUCIAL INFORMATION.
