QUESTION 3: WHAT IS A W-2 FORM, AND WHAT INFORMATION DOES IT CONTAIN?

ANSWER 3: A W-2 FORM IS ISSUED BY YOUR EMPLOYER AND REPORTS YOUR WAGES AND THE AMOUNT OF TAXES WITHHELD FROM YOUR PAYCHECK DURING THE TAX YEAR. IT'S CRUCIAL FOR FILING YOUR INCOME TAX RETURN.

QUESTION 4: WHAT IS A 1099-NEC FORM, AND WHO RECEIVES IT?

ANSWER 4: A 1099-NEC FORM REPORTS NON-EMPLOYEE COMPENSATION. INDEPENDENT CONTRACTORS, FREELANCERS, AND GIG WORKERS RECEIVE THIS FORM FROM THE CLIENTS THEY WORKED FOR DURING THE TAX YEAR, REPORTING THE PAYMENTS RECEIVED.

INDIVIDUALS AND FAMILIES. ELIGIBILITY IS BASED ON INCOME, FAMILY SIZE, AND FILING STATUS.

QUESTION 9: WHAT ARE CAPITAL GAINS, AND HOW ARE THEY TAXED DIFFERENTLY THAN ORDINARY INCOME?

ANSWER 9: CAPITAL GAINS ARE PROFITS FROM SELLING ASSETS LIKE STOCKS OR REAL ESTATE. THEY ARE TAXED AT DIFFERENT RATES THAN ORDINARY INCOME, WITH RATES VARYING BASED ON THE LENGTH OF TIME THE ASSET WAS HELD (SHORT-TERM VS. LONG-TERM).

ANSWER 13: FORM W-8BEN IS USED BY FOREIGN PERSONS TO CERTIFY THEIR FOREIGN STATUS FOR PURPOSES OF CLAIMING REDUCED OR EXEMPT TAX WITHHOLDING ON CERTAIN U.S.-SOURCE INCOME.
