Colonial American women relied on the same authorities and traditions as did colonial men, but they encountered special difficulties validating themselves in writing. William Scheick explores logonomic conflict in the works of northeastern

colonial women, whose writings often register anxiety not typical of their male contemporaries. This study features the poetry of Mary English and Anne Bradstreet, the letter-journals of Esther Edwards Burr and Sarah Prince, the autobiographical prose of Elizabeth Hanson and Elizabeth Ashbridge, and the political verse of Phyllis Wheatley. These works, along with the writings of other colonial women, provide especially noteworthy instances of bifurcations emanating from American colonial women's conflicted confiscation of male authority. Scheick reveals subtle authorial uneasiness and subtextual tensions caused by the attempt to draw legitimacy from male authorities and traditions.

Like William Shakespeare in his parody sonnet 'my mistress' eyes are nothing like the sun', Donne sends up the Petrarchan and courtly love genre with gross comparisons ('Like spermatic issue of ripe menstruous boils'). In 'The Bait', there is the archetypal Renaissance opening line 'Come live with me, and be my love', as used by Christopher Marlowe and William Shakespeare, among others. And there is the complex, ambivalent eroticism of 'The Extasie', a much celebrated love poem, and the 19th 'Elegy', where features Donne's famous couplet: Licence my roving hands, and let them go Before, behind, between, above, below. The Songs and Sonnets of John Donne celebrate the many emotions of love, feelings that are so familiar in love poetry from Sappho to Adrienne Rich. Donne does not quite cover every emotion of love, but a good deal of them. In 'The Canonization', we find the age-old Neo-platonic belief that two can become as one ('we two being one', or 'we shall/ Be one', he writes in 'Lovers' Infiniteness'), a common belief in love poetry. John Donne's love poetry, like (nearly) all love poetry, self-reflexive. Although he would 'ne'er parted be', as he writes in 'Song: Sweetest love, I do not go', he knows that love poetry comes out of loss. The beloved woman is not there, so art takes her place. The Songs and Sonnets arise from loss, loss of love; they take the place of love. For, if he were clasping his beloved in those feverish embraces as described in 'The Extasie' and 'Elegy', he would not, obviously, bother with poetry. Love poetry has this ambivalent, difficult relationship with love. The poem is not love, and is no real substitute for it. According to Joseph McElrath and Allan P. Robb it is known from autobiographical material that Bradstreet started to read the Bible at the very early age of six (xvi).

He also states that “. . . her thorough familiarity with the Bible artfully manifests itself in virtually everything she wrote” (xix). Therefore I argue that as a work of Puritan poetry Anne Bradstreet’s “The Flesh and the Spirit” is mainly inspired by biblical ideas. In my paper, I intend to identify the basic ideas derived from the Bible in the poem and the allusions to books of the New but also the Old Testament. For this purpose, I will examine which central concepts in Bradstreet’s poem stem from the Scripture and explain their meaning in the context of the Bible. Thus, the meaning of the poem itself should become clearer. For the analysis, I will use the knowledge I acquired by reading the Bible for several years and studying Protestant theology. In addition, I will consult a Bible concordance and linguistic critical literature.

Jordan's most quotable poems, however, return to the voice of the 13-year-old speller, who learned the word chiaroscuro/ By rolling it on my tongue// Like cotton candy the color/ Of day and night.
