1. Vision, Hearing, and Dental Services: These are typically not covered under Medicare Part B, and therefore, are not included in the AWW. You will need separate coverage for these services.

1. Mental Health Services: While a cognitive assessment is included, more extensive mental health evaluations or therapy are separate services and will be billed separately.

1. Physical Therapy, Occupational Therapy, and Other Therapies: Any kind of therapeutic intervention falls outside of the scope of the AWW. These are usually

covered under Part B with some requirements.

Review your Medicare plan details: Familiarize yourself with your specific coverage for preventive services.

Discuss potential costs: Clarify with your doctor or Medicare provider what services might be extra cost if needed based on the wellness visit.

The main findings of the report are that working-age Americans without health insurance are more likely to receive too little medical care and receive it too late; be sicker and die sooner; and receive poorer care when they are in the hospital, even for acute situations like a motor vehicle crash.
