TRANSITIONS: PAY ATTENTION TO WORDS AND PHRASES THAT SIGNAL SHIFTS IN THOUGHT OR DIRECTION (E.G., HOWEVER, THEREFORE, IN CONTRAST, FURTHERMORE).

CONCLUSION: ANALYZE HOW THE AUTHOR SUMMARIZES THE MAIN POINTS AND RESTATES THE THESIS IN A NEW LIGHT. LOOK FOR A CALL TO ACTION OR A FINAL THOUGHT.

HEADINGS AND SUBHEADINGS: THESE PROVIDE A ROADMAP TO THE TEXT'S ORGANIZATION, HIGHLIGHTING KEY TOPICS AND THEIR RELATIONSHIPS.

VISUAL AIDS: DIAGRAMS, CHARTS, AND IMAGES CONTRIBUTE TO THE OVERALL STRUCTURE AND SHOULD BE CONSIDERED IN THE ANALYSIS.

APPLYING STRUCTURAL ANALYSIS: A PRACTICAL EXAMPLE

BY IDENTIFYING THIS STRUCTURE, YOU CAN EASILY GRASP THE MAIN ARGUMENTS AND THE AUTHOR'S OVERALL MESSAGE.

TYPES OF TEXT STRUCTURES:
