Errors in the text grew in number in subsequent cheap editions of the poems, until, in 1872, a century after Thompson, and when I was a scholar at the old Granmiar School at Hull which claimed Marvell as one of its most distinguished pupils, Dr. Grosart published the first volume of a limited edition of Marvell's works. It may be said that that edition was the first in which any serious attempt was made to give an accurate text, or to explain the constant allusions to contemporary events. But greatly as I have been indebted to Dr. Grosart's work, much remained to be done.
