In contrast, others cited evidence that programs based on positive reinforcement alone were sometimes not effective in treating severe problems. The first editor approached Ogden Lindsley, president of ABA, about establishing a task force to examine this issue. The first editor was asked to chair the task force and appointed Saul Axelrod, Jon S. Bailey, Judith E. Favell, Richard M. Foxx, and O. Ivar Lovaas as members. Brian A. Iwata was appointed liaison by the ABA council.
