SYNTACTIC ANALYSIS OFTEN INVOLVES TREE DIAGRAMS AND FORMAL GRAMMARS, PROVIDING A VISUAL AND LOGICAL REPRESENTATION OF SENTENCE STRUCTURE. THIS ALLOWS LINGUISTS TO IDENTIFY UNDERLYING PATTERNS AND RULES GOVERNING SENTENCE FORMATION, REGARDLESS OF THE SURFACE-LEVEL VARIATION BETWEEN LANGUAGES.

PHONOLOGY: WHILE SYNTAX AND SEMANTICS DEAL WITH THE HIGHER LEVELS OF LANGUAGE STRUCTURE, PHONOLOGY FOCUSES ON THE SOUND SYSTEM. IT EXAMINES THE INVENTORY OF SOUNDS (PHONEMES) IN A LANGUAGE, HOW THESE SOUNDS ARE ORGANIZED, AND HOW THEY INTERACT WITH EACH OTHER. THE LOGICAL STRUCTURE IN PHONOLOGY OFTEN INVOLVES THE USE OF FORMAL MODELS TO REPRESENT SOUND PATTERNS AND RULES. FORMAL SEMANTICS: THIS APPROACH USES FORMAL LOGIC TO REPRESENT THE MEANING OF SENTENCES, ENABLING PRECISE

ANALYSIS OF MEANING RELATIONSHIPS. IT EMPLOYS TOOLS LIKE TRUTH-CONDITIONAL SEMANTICS AND MODEL-THEORETIC SEMANTICS TO PROVIDE RIGOROUS AND MATHEMATICALLY PRECISE DESCRIPTIONS OF MEANING.

OPTIMALITY THEORY: THIS FRAMEWORK ANALYZES LINGUISTIC VARIATION BY CONSIDERING COMPETING CONSTRAINTS ON GRAMMATICAL STRUCTURES.
