IF YOU EXPERIENCE ISSUES DUE TO OUTDATED INFORMATION, DOCUMENT THE PROBLEM AND TRY CONTACTING THE RELEVANT GOVERNMENT DEPARTMENT TO REPORT THE ISSUE. YOU MAY CONSIDER FILING AN RTI APPLICATION IF THE ISSUE IS NOT RESOLVED.
1. HOW OFTEN ARE GOVERNMENT MANUALS TYPICALLY UPDATED? THE FREQUENCY OF UPDATES VARIES DEPENDING ON THE DEPARTMENT AND THE SPECIFIC MANUAL. HOWEVER, IDEALLY, MANUALS SHOULD BE UPDATED REGULARLY TO REFLECT ANY POLICY CHANGES OR PROCEDURAL UPDATES.
1. WHAT ARE THE PENALTIES FOR PROVIDING CITIZENS WITH OUTDATED OR MISLEADING INFORMATION? PROVIDING CITIZENS WITH OUTDATED OR MISLEADING INFORMATION CAN LEAD TO DISCIPLINARY ACTIONS AGAINST GOVERNMENT EMPLOYEES, DEPENDING ON THE SEVERITY AND IMPACT OF THE MISINFORMATION.
