HE METICULOUSLY EXAMINES THE HISTORICAL RECORD, CITING NUMEROUS EXAMPLES WHERE WELL-INTENTIONED INITIATIVES HAVE YIELDED DISAPPOINTING OR EVEN NEGATIVE RESULTS. THE "PLANNERS VS. SEARCHERS" DICHOTOMY: TWO APPROACHES TO DEVELOPMENT

SEARCHERS PRIORITIZE LOCAL KNOWLEDGE, INDIVIDUAL AGENCY, AND CONTINUOUS ADAPTATION BASED ON FEEDBACK AND RESULTS. THIS APPROACH EMPHASIZES LEARNING THROUGH TRIAL AND ERROR, EMBRACING FAILURE AS A STEPPING STONE TOWARDS SUCCESS. EASTERLY CHAMPIONS THE SEARCHER'S APPROACH, ARGUING IT HOLDS THE KEY TO UNLOCKING SUSTAINABLE AND EQUITABLE GROWTH.

THE IMPORTANCE OF INSTITUTIONS AND INCENTIVES: CREATING AN ENABLING ENVIRONMENT
