CATHOLICISM, INITIALLY MARGINALIZED, GAINED A FOOTHOLD IN THE MARYLAND COLONY, DEMONSTRATING THE GROWING RELIGIOUS PLURALISM—ALBEIT A FRAGILE ONE—EVEN IN THE NASCENT NATION. THIS PERIOD ESTABLISHED THE FOUNDATIONAL CONFLICTS AND COLLABORATIONS THAT WOULD DEFINE SUBSEQUENT RELIGIOUS DEVELOPMENT.

H3: THE ROLE OF RELIGIOUS PERSECUTION AND TOLERATION:

RELIGIOUS PERSECUTION WAS A RECURRING THEME. THE SALEM WITCH TRIALS STAND AS A CHILLING REMINDER OF THE DANGERS OF RELIGIOUS EXTREMISM AND INTOLERANCE. H2: THE GREAT AWAKENINGS: REVIVALS AND REFORM (1730-1830)

THE GREAT AWAKENINGS, A SERIES OF RELIGIOUS REVIVALS, PROFOUNDLY IMPACTED THE AMERICAN RELIGIOUS LANDSCAPE. THESE REVIVALS EMPHASIZED EMOTIONAL EXPERIENCES OF FAITH, INDIVIDUAL CONVERSION, AND A REJECTION OF ESTABLISHED RELIGIOUS HIERARCHIES. H3: THE SECOND GREAT AWAKENING AND ITS SOCIAL RAMIFICATIONS:

THE SECOND GREAT AWAKENING FURTHER BROADENED THE REACH OF EVANGELICAL PROTESTANTISM. DESPITE THESE CHALLENGES, THE PRINCIPLE OF RELIGIOUS FREEDOM, ENSHRINED IN THE CONSTITUTION, GRADUALLY SOLIDIFIED, ALLOWING FOR A GREATER DEGREE OF RELIGIOUS TOLERANCE, THOUGH ONGOING STRUGGLES FOR EQUALITY PERSISTED, PARTICULARLY FOR MINORITY FAITHS.

H2: AMERICAN RELIGION IN THE 20TH AND 21ST CENTURIES: TRANSFORMATION AND CHALLENGES

THE 20TH AND 21ST CENTURIES HAVE BEEN MARKED BY SIGNIFICANT TRANSFORMATIONS WITHIN AMERICAN RELIGION.
