H2: BEYOND SEPARATION OF POWERS: OTHER KEY MONTESQUIEU CONCEPTS

IN AN ERA MARKED BY INCREASING CONCERNS ABOUT EXECUTIVE OVERREACH AND DEMOCRATIC BACKSLIDING, MONTESQUIEU'S WARNINGS REMAIN PROFOUNDLY RELEVANT.
