GRADUAL PRIVATIZATION: WHILE STATE-OWNED ENTERPRISES REMAINED DOMINANT, DENG ENCOURAGED THE GROWTH OF PRIVATE BUSINESSES, INJECTING COMPETITION AND INNOVATION INTO THE ECONOMY. THIS LED TO A BURGEONING PRIVATE SECTOR THAT FUELLED JOB CREATION AND ECONOMIC EXPANSION.
