CHAUCER'S ABILITY TO CAPTURE THE NUANCES OF HUMAN PERSONALITY, EVEN WITHIN A FEW LINES OF DESCRIPTION, IS REMARKABLE. THESE CHARACTERS AREN'T JUST STEREOTYPES; THEY ARE COMPLEX INDIVIDUALS WITH THEIR OWN MOTIVATIONS, FLAWS, AND AMBITIONS.

IV. SOCIAL COMMENTARY AND SATIRE: A MIRROR TO MEDIEVAL SOCIETY

THROUGH THESE CHARACTERS AND THEIR INTERACTIONS, CHAUCER SUBTLY EXPOSES THE INEQUALITIES AND INJUSTICES PREVALENT IN MEDIEVAL SOCIETY, MAKING THE PROLOGUE A SURPRISINGLY MODERN AND RELEVANT TEXT.

V. THE ENDURING LEGACY OF THE PROLOGUE: ITS IMPACT ON LITERATURE AND LANGUAGE
