THE NUMBERS ARE STAGGERING, WITH MILLIONS AFFECTED GLOBALLY, OFTEN HIDDEN WITHIN LARGER CONFLICTS AND LACKING THE INTERNATIONAL SPOTLIGHT ENJOYED BY REFUGEE CRISES.

1. THE GUIDING PRINCIPLES ON INTERNAL DISPLACEMENT (GPIDs): A CORNERSTONE OF PROTECTION

THE GUIDING PRINCIPLES ON INTERNAL DISPLACEMENT AREN’T LEGALLY BINDING TREATIES LIKE THE REFUGEE CONVENTION. ADOPTED IN 1998 BY THE UN’S GUIDING PRINCIPLES ON INTERNAL DISPLACEMENT (GPIDs), THEY SERVE AS A UNIVERSALLY ACCEPTED FRAMEWORK OUTLINING THE MINIMUM STANDARDS FOR THE PROTECTION AND ASSISTANCE OF IDPs. THESE PRINCIPLES PROVIDE A CRUCIAL REFERENCE POINT FOR GOVERNMENTS, HUMANITARIAN ORGANIZATIONS, AND OTHER ACTORS INVOLVED IN RESPONDING TO DISPLACEMENT SITUATIONS.

1. KEY PRINCIPLES FOR PROTECTING IDPs:

THE GPIDs ARTICULATE SEVERAL CORE PRINCIPLES:

NON-REFOULEMENT: STATES ARE PROHIBITED FROM RETURNING IDPs TO AREAS WHERE THEIR LIFE, SAFETY, OR FREEDOM WOULD BE THREATENED. THIS PRINCIPLE IS PARAMOUNT, PREVENTING THE CYCLICAL NATURE OF DISPLACEMENT.

FUNDING GAPS: CHRONIC UNDERFUNDING OF HUMANITARIAN OPERATIONS SEVERELY RESTRICTS THE CAPACITY TO PROVIDE ADEQUATE ASSISTANCE TO IDPs. FUNDING MECHANISMS NEED TO BE STRENGTHENED.

COORDINATION CHALLENGES: EFFECTIVE RESPONSE REQUIRES STRONG COORDINATION AMONG VARIOUS ACTORS, INCLUDING GOVERNMENTS, INTERNATIONAL ORGANIZATIONS, AND NGOS. GAPS IN COORDINATION CAN LEAD TO INEFFECTIVE RESPONSES.
